# **RPV FACILITY**

Shareholder(s)/proxy(ies)/corporate representative(s)/attorney(s) are to participate, communicate and vote (collectively, "participate") remotely at the 27<sup>th</sup> AGM using RPV provided by AGRITEUM via its website at www.agriteum.com.my ("AGRITEUM Portal").

If you wish to submit your questions via the AGRITEUM Portal, you must first register as an user at the AGRITEUM Portal. Thereafter, you may select << My Virtual Meeting>> under the Main Menu and click on the Q&A platform to post your question(s).

Shareholders may use the Q&A platform to submit questions in real time during the 27<sup>th</sup> AGM. Shareholders may also submit questions to the Board prior to the 27<sup>th</sup> AGM via the Q&A platform in the AGRITEUM Portal from 12.00 pm on 24 September 2021 up to 9.30 am on 30 September 2021. If there is time constraint in answering the questions during the 27<sup>th</sup> AGM, the questions will be answered through email.

(iv) Participate through Live Streaming	<ul> <li>Select the &lt;<virtual meeting="">&gt; from main menu.</virtual></li> <li>Click &lt;<join meeting="">&gt; in order to join the live streaming of the 27<sup>th</sup> AGM.</join></li> <li>If you have any question(s) during the 27<sup>th</sup> AGM, you may use the Q&amp;A platform in ZOOM Cloud Meetings App to submit your question(s). The Chairman of the 27<sup>th</sup> AGM ("Chairman")/ Board/Management will try to respond to all relevant questions submitted during the 27<sup>th</sup> AGM. If there is time constraint in answering the questions during the 27<sup>th</sup> AGM, the questions will be answered through email.</li> <li>If you are using a smartphone to participate in the 27<sup>th</sup> AGM, please download ZOOM Cloud Meetings App before the 27<sup>th</sup> AGM.</li> <li>Please take note that the quality of the live streaming is dependent on the bandwidth and stability of the internet connection at your location.</li> </ul>	
(v) Online remote voting	<ul> <li>Please select the &lt;<voting>&gt; option located next to &lt;<join meeting="">&gt; to indicate your votes for the resolutions that are tabled for voting.</join></voting></li> <li>Voting session will commence once the Chairman declares that the voting platform is activated. The voting session will end upon declaration by the Chairman.</li> <li>Please cast your vote on all resolutions as appeared on the screen and submit your votes. Once submitted, your votes will be final and cannot be changed.</li> </ul>	
(vi) End of RPV Facility	• The RPV Facility will end and the Q&A platform will be disabled the moment the Chairman announces the closure of the 27 <sup>th</sup> AGM.	

## Notes to users of the RPV Facility:

- (a) Should your registration as user be approved, we will make available to you the rights to join the live-streamed 27<sup>th</sup> AGM and to vote remotely using the RPV Facility. Your login to the AGRITEUM Portal on the day of the 27<sup>th</sup> AGM will indicate your presence at the 27<sup>th</sup> AGM.

# RECORD OF DEPOSITORS ("ROD") FOR THE 27<sup>th</sup> AGM

Only shareholders whose names appear on the ROD as at 22 September 2021 shall be entitled to participate or appoint proxy(ies) to participate at the 27<sup>th</sup> AGM via the RPV Facility.

## **PROXY**

- 1. The 27<sup>th</sup> AGM will be conducted on a fully virtual basis. If you are unable to participate the 27<sup>th</sup> AGM, you may appoint the Chairman as proxy and indicate the voting instructions in the Form of Proxy.
- 2. If you wish to appoint proxy(ies) to participate in the 27<sup>th</sup> AGM using the RPV Facility, the Form of Proxy must be completed and deposited at the Company registered office at 170-09-01, Livingston Tower, Jalan Argyll, 10050 George Town, Penang, Malaysia not less than forty-eight (48) hours before the time fixed for holding the 27<sup>th</sup> AGM. Please refer to the Form of Proxy for the details.
- 3. Shareholders who have appointed a proxy/authorised representative/attorney to participate at the 27<sup>th</sup> AGM via the RPV Facility must ensure that his/her proxy/authorised representative/attorney register himself/herself at the AGRITEUM Portal prior to the 27<sup>th</sup> AGM.

## **REVOCATION OF PROXY**

If you have submitted your Form of Proxy and subsequently decide to appoint another person or wish to participate in the 27<sup>th</sup> AGM by yourself, please write in to AGRITEUM not less than forty-eight (48) hours before the time fixed for holding the 27<sup>th</sup> AGM to revoke the earlier appointed proxy.

#### **POLL VOTING**

- 1. All resolutions set out in the Notice of the 27<sup>th</sup> AGM shall be put to vote by way of a poll pursuant to Paragraph 8.29A(1) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("**Bursa Securities**"). The Company has appointed AGRITEUM as Poll Administrator to conduct the poll by way of electronic means and Symphony Merchant Sdn. Bhd. as Independent Scrutineers to verify the poll results.
- 2. Upon completion of the voting session, the Independent Scrutineers will verify the poll results followed by the declaration of results by the Chairman.

Please note that it is your responsibility to ensure the stability of your internet connectivity throughout the  $27^{th}$  AGM as the quality of the live webcast and online remote voting are dependent on your internet bandwidth and stability of your internet connection.
